Green Arrow Capital's Mi.To Real Estate Fund announces partnership with Cracking Art to promote art in urban areas

The collaboration entails the installation of artwork from the artistic movement in residential complexes developed by the Mi.To Fund, symbolically reflecting its goal of urban regeneration

Milan, 20 March 2025 – The Mi.To Real Estate Fund, a Green Arrow Capital and Crea.Re Advisory initiative focused on the mid-size residential real estate market, primarily in Milan and Turin, has signed a partnership with Cracking Art, an artistic movement founded in 1993, known for its strong social and environmental commitment. The partnership aims to promote art within the urban regeneration projects that the Fund is implementing in the city centers of both locations.

Notably, the collaboration will see Cracking Art's works installed in Mi.To's residential complexes, transforming them into iconic and instantly recognisable places, while also celebrating Italian artistic heritage. Art lies at the core of the partnership, serving as a meeting point for the shared values of innovation and sustainability that unite the Fund and Movement.

Thanks to the partnership with Cracking Art, the project also integrates art as a tool for regeneration and social awareness.

CRACKING ART

The Cracking Art movement (www.crackingart.com) is distingushed by a strong commitment to social and environmental causes, combined with the innovative use of plastic in order to highlight the relationship between nature and artifice. The name is inspired by "catalytic cracking", a chemical process that transforms petroleum into plastic, symbolising the shift from organic to synthetic. The artwork, such as the iconic coloured animals, transforms urban and public spaces, and sparks a dialogue on humanity's impact on the environment. Regenerating plastic means saving it from destruction and giving it a new, artistic life, transforming it into an expressive language that can bring awareness to the public on the environmental and social issues of our times.
